ARTICLES OF INCORPORATION

of

EDWARDS LANDSCAPING INC.

ARTICLE I - NAME

The name of the corporation is ----- EDWARDS LANDSCAPING INC.
and whose principal office location is 8507 WOODDALE CT
TAMPA FL 33615

ARTICLE II - DURATION

This corporation shall exist perpetually.

ARTICLE III - PURPOSE

This corporation is organized for the following purposes:

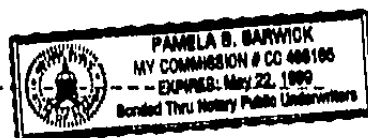
