## PRIORITY AMENDMENTS AND CHANGES

This corporation reserves the right to smend, after, change or repeal any provision contained in these Articles of Incorporation in the manner new or hereafter prescribed by statute or sat out in the corporate By-Laws so long as same does not conflict with the yloride Statutes.

The Directors of this corporation shall have the power to make or amend the By-Laws and to fix any amount to be reserved for working capital.

The private property of the stockholders shall not be subject to the payment of the corporate debts in any extent whatsoever. The corporation shall have a first lien on the shares of its members and upon the dividends due them for any indebtedness of such members of the corporation.
