I, the undersigned, hereby make, subscribe, acknowledge and file with the Secretary of State of the State of Florida these Articles of Incorporation for the purpose of forming a corporation for profit in accordance with the laws of the State of Florida.

ARTICLE I

Name

The name of this corporation shall be **AIRCRAFT SPECIALTIES CORPORATION.**

ARTICLE II

Principal Place of Business / Mailing Address

The principal place of business and mailing address of the corporation is St. Petersburg Clearwater International, Airport Hanger 3, Clearwater, Florida 34622.

ARTICLE III

Duration

The corporation shall begin its existence as of the date of filing and shall exist perpetually.

ARTICLE IV

Purpose

The purpose of the corporation is to transact any of all lawful business for which corporations may be incorporated under Chapter 607, Florida Statutes.

ARTICLE V

Capital Stock

The total number of shares of capital stock authorized to be issued by the corporation shall be five thousand (5,000) having a par value of one dollar (\$1.00) per share. All shares are designated as common stock and shall have identical rights and privileges in every respect.

ARTICLE VI
Preemptive Rights

Each shareholder upon the sale for cash by this corporation of any new capital stock of the same kind, class, or series as that which he or she already holds, shall have the preemptive right to purchase his or her prorata share thereof (as nearly as may be done without the issuance of fractional shares).

ARTICLE VII
Commencement of Business

The corporation shall not commence business until it has received from the issuance of its shares consideration of the value of One Thousand Dollars (\$1,000) consisting of money, labor done or property actually received.

ARTICLE VIII
Registered Office and Registered Agent

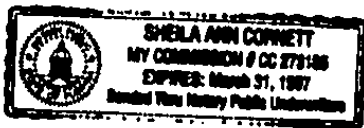
