
To whom it might concern,

On the 29<sup>th</sup> of July 1998, I was informed that this corporation had been dissolved as of 26 September, 1997. We were unaware of this event because we never received any notice. Upon checking into why we never received any mail from the state, I found out the following. The address of the corporation is Hanger #3 St. Petersburg-Clearwater International Airport, Clearwater, Florida 34762. It happens that there are two hangers designated Hanger #3 on the airport premises. Until last week, neither premises had an official address for postal deliveries. Consequently, there has been much confusion with mail delivery. According to people at the other hanger #3, much mis-delivered mail is simply thrown away. It seems that this was probably the fate of our notices from that State of Florida regarding our corporate status. Since it is fairly obvious that the address confusion caused us to be unaware of the corporate status, We ask that the State please refrain from charging us the \$600.00 reinstatement fee as we would have never been delinquent if we had been able to receive the notice.

Last week, Pinellas County assigned official street addresses to all of the structures at this airport.

Your consideration of our problem will be greatly appreciated.
