OF

ARTICLE I. NAME: The name of the corporation is Dr. William Glover, III, P. A.

ARTICLE II. PURPOSE: This corporation is organized for the purpose of the transaction of any lawful business for which corporations may be incorporated under the laws of the United States and the State of Florida. This professional service corporation will be in the practice of dentistry.

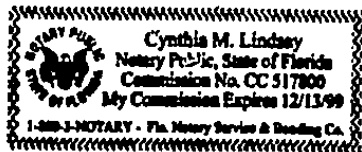


