ARTICLES OF INCORPORATION OF DUNHAM STUCCO & LATH, INC.

The undersigned, hereby executes the following for the purpose of forming a corporation under the General Corporation Act of the State of Florida providing for the formation, liabilities rights, privileges and immunities of a corporation for profit.

ARTICLE I

The name of the corporation shall be DUNHAM STUCCO & LATH, INC.

ARTICLE II

This corporation shall have a perpetual existence unless sooner dissolved according to law.

ARTICLE III

The corporation is organized for the purpose of preforming STUCCO AND PLACTERING CONTRACTING to business and the general public, and any and all lawful business under the laws of the State of Florida and the United States.

ARTICLE IV CAPITAL STOCK

The authorized capital stock of the corporation shall be 600 shares of common stock at \$ 1.00 par value each. Such stock shall be issued by the Board of Directors is equivalent to such market value thereof, and said stock may be paid for in money or tangible personal property, but not for labor, service or stock, at a just valuation to be fixed by the Board of Directors or issued as partly paid when so ordered by the Board of Directors.

ARTICLE V PREEMPTIVE RIGHTS

Each shareholder shall have the right to purchase, subscribe for, or receive a right or rights to purchase any stock of any class that the corporation may issue or sell, whether or not exchangeable for any stock of the corporation of any class or classed, and whether or not of unissued shares authorized by the articles of the corporation as originally filled or by any amendment thereof or out of shares of stock of the corporation acquired by it after the issuance thereof, and weather issue for cash, labor done, personal property, or real property or leases thereof. These provisions as to preemptive rights shall not be amended, rescinded, or otherwise altered in any manner except by unanimous vote of the shareholders.
