# ARTICLES OF INCORPORATION

#### FOR

# SPYGLASS CAPITAL TRADING COMPANY

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, hereby accepts the following Articles of Incorporation:

### ARTICLE I

### NAME

The name of the corporation is SPYGLASS CAPITAL TRADING COMPANY.

## ARTICLE II

### DURATION

The term of existence of the corporation is perpetual.

### ARTICLE III

### **PURPOSE**

The corporation may transact any and all lawful business for which corporations may be incorporated under the Florida General Corporation Act.

### ARTICLE IV

### CAPITAL STOCK

The corporation is authorized to issue One Thousand (1,000) shares of One Dollars (\$1.00) par value common stock, which shall be designated "Common Shares".

### ARTICLE V
