

ARTICLES OF INCORPORATION

I, the undersigned Incorporator, a person duly licensed to practice nursing under the laws of the State of Florida, hereby present these Articles for the formation of a professional corporation for pecuniary profit under the provisions of Chapter 607 and Chapter 621, Florida Statutes.

ARTICLE I

NAME OF CORPORATION

The name of the corporation shall be:

SANDRA REGUEIRO, R.N., P.A.

The address of the principal office of this corporation shall be 8600 N.W. 49th Drive, Coral Springs, Florida 33067, and the mailing address of the corporation shall be the same.

ARTICLE II

NATURE OF BUSINESS

The general nature of the business and the proposed objects and purposes to be transacted, promoted and carried on are to do any and all things hereinafter mentioned, as fully and to the same effect and extent as natural persons might or could do, viz:

A. To engage in the practice of nursing under the laws of the State of Florida.

B. To render professional services only through its officers, agents and employees who are duly licensed or otherwise legally authorized within the State of Florida to render the same professional service as this corporation.

C. To invest its funds in real estate, mortgages, stocks, bonds and any other types of investments.

D. To own real and personal property necessary for the rendering of the professional services hereby authorized.

E. To do all and everything necessary or convenient to effect any of its purposes.

F. This corporation shall not engage in any business other than the practice of nursing.

ARTICLE III

CAPITAL STOCK

The maximum number of shares that this corporation is authorized to have outstanding at any one time is 7,500 shares of common stock.

ARTICLE IV


