The name of this corporation is

This corporation shall exist perpetually, commencing on the

The corporation shall have all of the corporate powers including acting as trustee, and those enumerated in the Florida Statute covering Professional Associations.

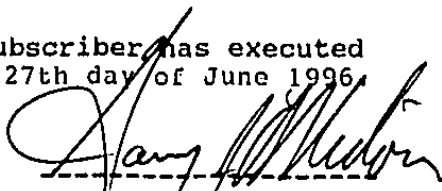
ARTICLE X-INDEMNIFICATION

ARTICLE XI-AMENDMENTS

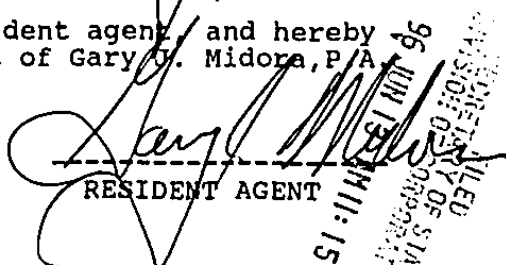
