ARTICLES OF INCORPORATION

OF

THE CROSIER GROUP, INC.

We, the undersigned incorporators, hereby make, subscribe, acknowledge and alle with the Secretary of State of Florida, these Articles of Incorporation for the purpose of forming a corporation for profit in accordance with the laws of the State of Florida, Chapter 607.

ARTICLE I

Name
