Pursuant to 607.1403, Florida Statutes, this Florida for profit corporation submits the following Articles of Dissolution and requests that the Department of State dissolve the corporation effective as of the 6th day of April, 1998.

ARTICLE I - NAME OF CORPORATION

The name of the corporation is **A Blue Tulip, Inc.** (hereinafter referred to as the "Corporation").

ARTICLE II - DATE OF AUTHORIZATION

The dissolution was authorized by the unanimous consent of the Shareholders and the Board of Directors on March 15, 1998.

ARTICLE III - ADOPTION OF DISSOLUTION

These Articles of Dissolution were adopted and approved by the holders of all of the outstanding shares of common stock of the Corporation as the sole voting group of the corporation, by a unanimous written consent executed on March 15, 1998, which constituted a sufficient vote for approval by the shareholders.

ARTICLE IV - EFFECTIVE DATE OF DISSOLUTION

The Corporation shall be effectively dissolved on April 6, 1998.
