## ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF SIMPSON TRAINING CENTER, INC.

The undersigned hereby certifies that by unanimous written consent in lieu of a special joint meeting of board of the directors and shareholders of Simpson Training Center, Inc.(the "Corporation"), these Articles of Amendment to the Articles of Incorporation of the Corporation were unanimously adopted by all of the Directors and shareholders of the Corporation on April 7, 2000.
