We, the undersigned, being desirous of associating ourselves together for the purpose of forming a corporation for profit under the laws of the State of Florida, do make, subscribe and acknowledge these Articles of Incorporation, pursuant to Chapter 607 of the Florida Business Corporation Act, and other applicable provisions of the Corporation Law of the state of Florida, and acts amendatory thereof and supplemental thereto.

FIRST: The name of the corporation is Melvin, Inc.

SECOND: The purpose of the corporation is to engage in any lawful act or activity for which corporations may be organized under the corporation laws of the State of Florida.

THIRD: The corporation shall be authorized to issue one class of shares of Two Hundred (200) shares, \$.10 par value.

FOURTH: The address of the initial registered and principal office of this corporation in this state is c/o Melvin Cantor, 147 Prescott H Century Village, Deerfield Beach, Florida 33442 and the name of the registered agent at said address is Melvin Cantor.

SIXTH: The number of directors constituting the initial Board of Directors is one (1) and the name and address of the initial Board of Directors, to serve until the first annual meeting of shareholders, or until the successors are elected and qualify are as follows:

SEVENTH: Any person who was or is a party or is threatened to be made a party to any proceeding, (whether or not by or in the right of the corporation) by reason of the fact that he is or was a director, officer, employee, or agent of the corporation or is or was serving at the request of the corporation as a director, officer, employee or agent of another corporation, partnership, joint venture, trust or other enterprise, shall be entitled to be indemnified by the corporation to the full extent then permitted by law against liability incurred in connection with such proceeding, including any appeal thereof. Such right of

indomnification shall inure whether or not the claim asserted is based on matters which antodate the adoption of this Article Such right of indemnification shall concinue as to a person who has ceased to be a director, officer, employee or agent and shall inure to the benefit of the heirs and personal representatives of such a person. This indemnification provided by this Article SEVENTH shall not be deemed exclusive of any other rights which may be provided now or in the future under any provision currently in effect or hereafter adopted by the By-laws, by any agreement, by vote of stockholders, by resolution of disinterested directors, by provision of law, or otherwise.

No director of the corporation shall be EIGHTH: personally liable to the corporation or any other person for monetary damages for breach of fiduciary duty as a director, except for liability (i) for a violation of criminal law, unless the director has reasonable cause to believe his conduct was lawful or had no reasonable cause to believe his conduct was unlawful, (ii) for any transaction from which the director directly or indirectly derived an improper personal benefit, (iii) under section 607.144 of the Florida General Corporation Act, (iv) for conscious disregard for the best interest of the corporation or willful misconduct or (v) for recklessness or an act or omission in bad faith or with a malicious purpose or in a manner exhibiting wanton and willful disregard of human rights, safety or property.
