ARTICLES OF INCORPORATION

The undersigned, acting as incorporator of a corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation for such corporation.

ARTICLE_I

MANE AND ADDRESS

1. The name of this corporation is Business Printing Services & Computer Forms, Inc. and the address of the corporation is 1600 Mercer Avenue, Unit 3, West Palm Beach, Florida 33401.

ARTICLE_II

DURATION

2. The duration of this corporation shall be perpetual.
