The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, does hereby form a corporation for profit under the laws of the State of Florida.

ARTICLE I - NAME

The name of the corporation is Carlos Z. Delira, Inc.

ARTICLE II - DURATION

The Corporation shall have a perpetual existence unless dissolved according to law.

ARTICLE III - PURPOSE

The purpose of this Corporation is to engage in the business of carpet installation permitted under the Laws of the United States and Florida. The corporation shall have power to do everything necessary, proper, advisable and convenient for the accomplishment of the purposes hereinafter set and to do all other things incidental thereto or connected therewith which are not prohibited by statue or by these Articles of Incorporation.

ARTICLE IV - CAPITAL STOCK

The maximum number of shares which this corporation is authorized to have outstanding at any time is 100 shares of common stock having a par value of One Dollar (\$1.00) per share, each of which shall have the same rights and privileges.

ARTICLE V - INITIAL REGISTERED
