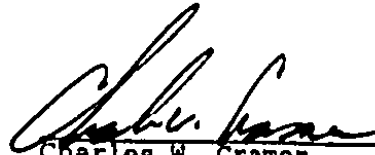

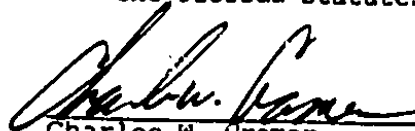
ARTICLE VI: DATES OF EXISTENCE
