ARTICLE I NAME

ARTICLE VII LIMITATION OF LIABILITY

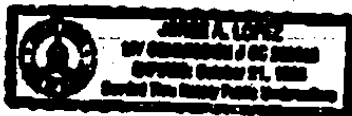

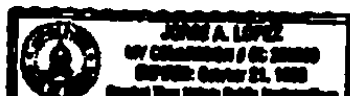
