The undersigned, for the purpose of forming a for profit corporation under the Florida General Corporation Act hereby adopts the following Articles of Incorporation.

ARTICLE ONE

The name of the Corporation is Chiefland Enterprises, Inc.

ARTICLE TWO

The term of existence of the Corporation is perpetual.

ARTICLE THREE PURPOSE

The purposes for which the Corporation is formed is to engage in the making of motor vehicle title loans and may, in addition, engage in any and all lawful businesses for which corporations may be incorporated under the Florida General Corporation Act.
