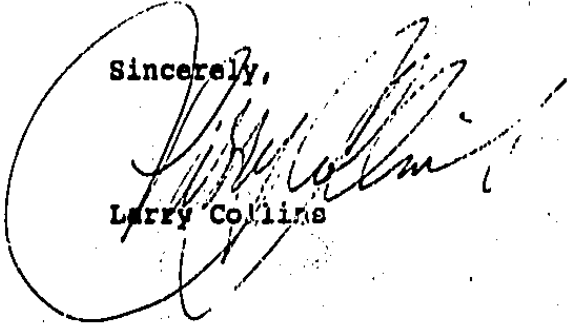

**ARTICLES OF INCORPORATION  
OF

The undersigned, for the purpose of forming a for-profit corporation under the Florida General Corporation Act hereby adopts the following Articles of Incorporation.

**ARTICLE ONE  
NAME**

The name of the Corporation is Chiefland Enterprises, Inc.

**ARTICLE TWO  
DURATION**

The term of existence of the Corporation is perpetual.

**ARTICLE THREE

The purposes for which the Corporation is formed is to engage in the making of motor vehicle title loans and may, in addition, engage in any and all lawful businesses for which corporations may be incorporated under the Florida General Corporation Act.

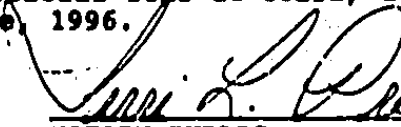

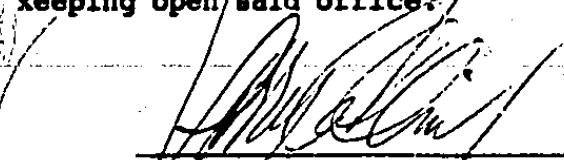
