THE UNDERSIGNED subscriber to these ARTICLES OF INCORPORATION, being a natural person competent to contract, does hereby forms a corporation for profit under the laws of the State of Florida.

ARTICLE I NAME

THE NAME of the corporation shall be MARR, IMC.

ARTICLE II PURPOSE

Any director of the corporation may vote upon any transaction with the corporation without regard to the fact that he is also a director of such subsidiary or corporation.
