The undersigned incorporator, a natural person competent to contract, hereby makes, subscribes, acknowledges, and files these Articles of Incorporation for the purpose of becoming a corporation under the laws of the State of Florida.

ARTICLE I
Name of Corporation

The name of the corporation shall be JEFFREY ALLEN McCANN, P.A.

ARTICLE II
Principal Place of Business

The principal place of business of the corporation shall be:

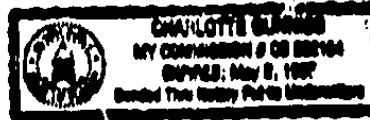
