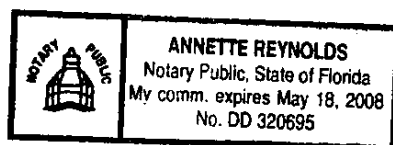
1. Ronald J. Beach is the President of NORTEK ENGINEERING SERVICES, INC., a Florida corporation, (hereinafter "Corporation").
