# ARTICLES OF INCORPORATION OF DONALD R. TROMBLEY & ASSOCIATES, INC.

The undersigned incorporator, a natural person for the purpose of organizing a corporation for conducting the business and promoting the purposes hereinafter stated, under the provisions and subject to the requirements of the Laws of the State of Florida, hereby certifies as follows:

# **ARTICLE I**

# Name

The name of this Corporation is: DONALD R. TROMBLEY & ASSOCIATES FINC.

# **ARTICLE II**

# Address

The address, including number, city and office of the Corporation is: 216 N. 5th Street, City of Leesburg, County of Lake, State of Florida 34748.

## **ARTICLE III**

# Term of Existence

This Corporation shall have perpetual existence, commencing July 1, 1996.

# **ARTICLE IV**

#### Purpose

This Corporation is organized for the purpose of transacting any and all lawful business.

## ARTICLE IV

# Election of Status as a Small Business Corporation

This Corporation shall by the filing of an election, consented to by all the shareholders, in accordance with the provisions of Section 1362(a) of the Internal Revenue Code of 1986, as amended.

#### **ARTICLE V**

#### Powers

The Corporation shall have the power:

- (a) To have perpetual succession by its corporate name.
- (b) To sue and be sued, complain and defend in its corporate name in all actions or proceeding.
- O To have a corporate seal, which may be altered at pleasure, and to use the same by causing it, or a facsimile thereof, to be impressed, affixed, or in any other manner reproduced.
- (d) To purchase, take, receive, lease, or otherwise acquire, own, hold, improve, use and otherwise deal with real or personal property or any interest therein, wherever situated.
- (e) To sell, convey, mortgage, pledge, create a security interest in, lease, exchange, transfer and otherwise dispose of all or any part of its property or assets.
- (f) To lend money to and use its credit to assist its officers and employees to the full extent permitted by law.
- (g) To purchase, take, receive, subscribe for, or otherwise acquire, own, hold, vote, use employ, sell, mortgage, lend, pledge, or otherwise dispose of, and otherwise use and deal in and with, shares or other interests in, or obligations of, other domestic or foreign corporations, essociations, partnerships or individuals, or direct or indirect obligations of the United States or any other government, state, territory, governmental district, or municipality or of any instrumentality thereof.

- (h) To make contracts and guarantees and incur liabilities, borrow money at such rates of interest as the Corporation may determine, issue its notes, bonds and other obligations as well as secure any of its obligations by mortgage or pledge of all or any of its property, franchises and income.
- (I) To lend money for its corporate purposes, invest and relevest its funds, and take and hold real and personal property as security for the payment of funds so loaned or invested.
- (j) To conduct its business, carry on its operations, and have offices and exercise the powers granted by the Florida General Corporation Act within and without the State of Florida.
- (k) To elect or appoint officers and agents of the Corporation and define their duties and fix their compensation.
- (1) To make and alter bylaws, not inconsistent with these Articles of Incorporation and the laws of this State, for the administration and regulation of the affairs of the Corporation.
- (m) To make donations for the public welfare or for charitable, scientific or educational purposes.
- (n) To transact any lawful business which the Board of Directors shall find will be in aid of governmental policy.
- (o) To pay pensions and establish and carry out pension plans, profit sharing plans, stock bonus plans, stock option plans, benefit plans and other incentive and compensation plans for any and all of the directors, officers, and employees of its subsidiaries.
- (p) To provide insurance for its benefit on the life of any of its directors, officers, or employees or on the life of any shareholder for the purpose of acquiring at his death shares of its stock owned by the shareholder or by the spouse or children of the shareholder.
- (q) To be a promoter, incorporator, general partner, limited partner, joint venture, trust or other enterprise.

#### **ARTICLE VI**

#### Capital Stock

This Corporation is authorized to issue 1,000 shares of no par (\$0) value common stock, which shall be designated Common Shares.
