**ARTICLE I - NAME**

The name of this corporation shall be:

**ARTICLE II - NATURE OF BUSINESS**

**ARTICLE III - DURATION**

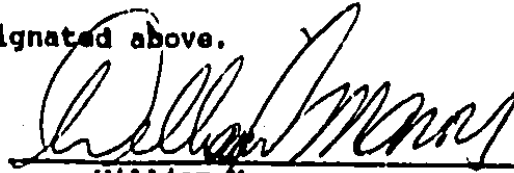
