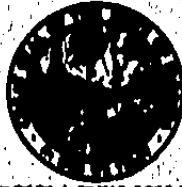

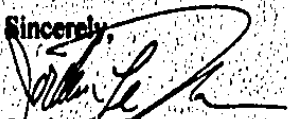

ARTICLES OF INCORPORATION

ARTICLE I NAME

The name of the corporation shall be: **NASEC, INC.**

ARTICLE II PRINCIPAL OFFICE

The address of the principal office is:

ARTICLE III SHARES

This corporation is authorized to issue shares of stock as follows:

- A. Designation: The stock of this Corporation shall be known as Common Stock.
- B. Authorized: The maximum number of share of Common Stock that this Corporation may issue is 100.
- C. Par Value: Each share of common Stock shall have the par value of \$5.00.
- D. Consideration: Shares of Common Stock may be issued in exchange for Cash, real estate property, labor or services rendered, or any combination for the forgoing. In the absence of fraud in the transaction, the judgment of the Board of Directors as to the value of any such consideration shall be exclusive.

- F. Voting rights: Each share of Common Stock entitle the record holder thereof to one upon each proposal presented in meetings of the shareholder of the Corporation.
- G. Cumulative Voting: No holder of the Common Stock shall be entitled to right cumulative voting.
- H. Dividend: Record holder of Common Stock are entitle, in the event of the liquidation of dissolution of this Corporation remaining after payment of all corporate debts and obligations.

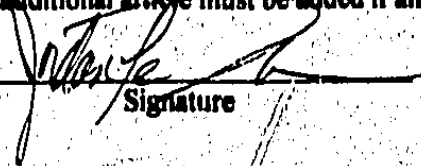

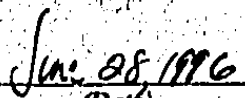
