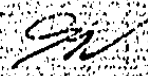

**ARTICLES OF INCORPORATION  
OF

The undersigned natural person, who is licensed to practice law in the State of Florida, with the intention of forming a professional corporation in accordance with the Florida Professional Service Corporation Act, hereby adopts the following articles of incorporation for such corporation:

**ARTICLE I. NAME**

The name of the corporation is The Accident Law Office of Samuel W. Bearman,  
P.A.

**ARTICLE II. PURPOSE**

This corporation is organized for the following purposes.

- a. To engage in the practice of law as a professional law corporation and to carry on services incident thereto. The practice of law is the sole and exclusive professional service to be rendered by this corporation.
- b. To own property, enter into contracts, and to carry on any business necessary or incidental to the accomplishment or furtherance of the purposes or objects of this corporation.

c. The professional services of this corporation shall be carried out only through officers, employees, and agents, each of whom has been admitted to the bar, and is duly authorized to practice law in, the State of Florida.

### **ARTICLE III. CAPITAL STOCK**

The total number of shares of capital stock which the corporation shall be authorized to issue is 500 shares. Such shares shall be of a single class of common stock, and shall have a par value of One Dollar (\$1.00) per share.

### **ARTICLE IV. CAPITALIZATION**

The amount of capital with which the corporation will begin to practice the profession of law is not less than Five Hundred Dollars (\$500.00).

### **ARTICLE V. DURATION**

The corporation shall have perpetual existence. Corporate existence shall commence on July 1, 1996.

### **ARTICLE VI. PRINCIPAL OFFICE**

The initial street address of the corporation's principal office is 817 North Palafox Street, Pensacola, Florida 32501.

## **ARTICLE VII. MANAGEMENT BY SHAREHOLDERS**

The corporation shall be a close corporation within the meaning of, and governed by, the Florida Close Corporation Act. The business of the corporation shall be managed by its shareholders pursuant to Section 608.72 of the Florida Statutes, and there shall be no directors.

## **ARTICLE VIII. SUBSCRIBERS**

## **ARTICLE IX. DISSOLUTION**

The corporation may be dissolved at any time by written consent of the sole shareholders. On dissolution, the corporate property and assets shall, after payment of all debts of the corporation, be distributed to the shareholders pro rata, each shareholder to participate in the distribution in direct proportion to the number of shares hold by him.
