AMENDMENT

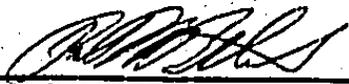

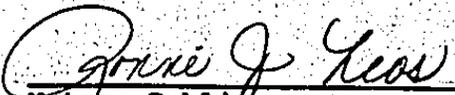

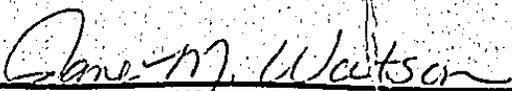
