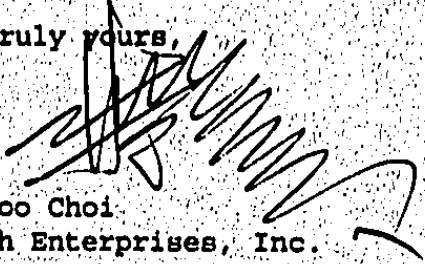

**CORPORATE NAME**

The name of this corporation is CH & CH ENTERPRISES, INC.

**ARTICLE II**

**PURPOSE**
