The undersigned incorporator to these Articles of Incorporation, a natural person competent to contract, hereby creates a corporation under the laws of the State of Florida.

**ARTICLE I**

The name of this corporation shall be **GRAHAM-ROGERS MORTUARY, INC.**, and its initial post office address and its principal office for the conduct of business is 3031 Moncrief Road, Jacksonville, Florida 32009.

**ARTICLE II**

The duration of the corporation is to be perpetual and shall commence its corporate existence upon the filing of the Articles of Incorporation by the Department of State.

**ARTICLE III**

The general purpose for which this corporation is organized is for the transaction of any and all lawful business for which corporations may be incorporated under Florida Statute 607.

**ARTICLE IV**
