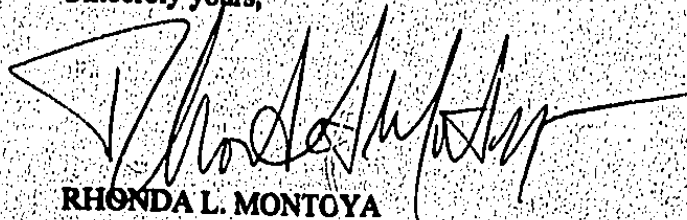

CORPORATE NAME

ARTICLE IV

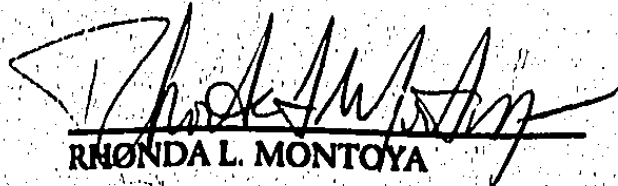

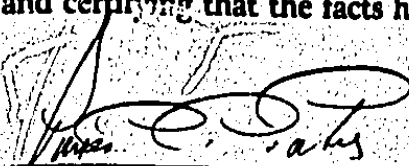
