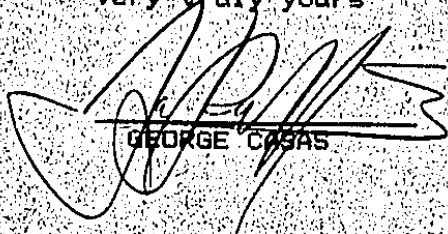

ARTICLE OF INCORPORATION OF

The undersigned, for the purpose of forming a corporation for profit under the Florida General Corporation Act, does hereby adopt the following Article of Incorporation.

ARTICLE I

The name of this corporation is Asagro - Casas, Inc.

ARTICLE II

Term of Existence

This corporation shall commence on the date of the filing of these Articles with the Secretary of State and shall have perpetual existence.

ARTICLE III

Nature of Business

This corporation may engage in any activity or business permitted under the laws of the United States and of this State.

ARTICLE IV

Capital Structure

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is 3000 shares of common stock, having a par value \$1.00 per share.

ARTICLE V

Initial Registered Agent and Registered Office

The initial registered agent of the corporation shall be GEORGE CASAS. The street address of the principal office and registered office is 2123 St. Marteen Ct., Kissimmee, Fl. 34741.

ARTICLE VI

Board of Directors

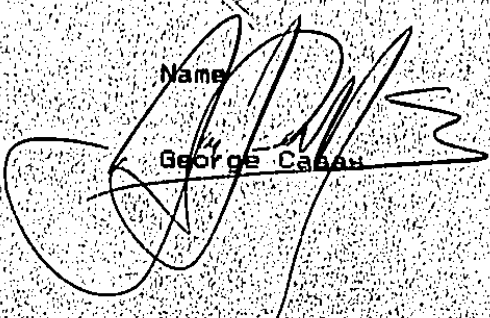

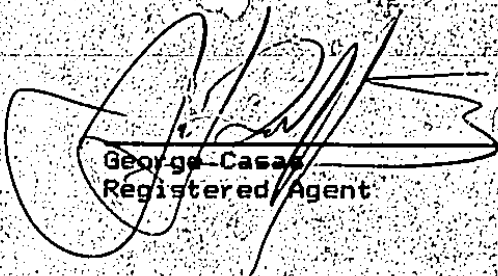
