The undersigned, acting as incorporator of a corporation under the Florida Business Corporation Act, adopt the following articles of incorporation for such corporation:

NAME

The name of this corporation is Joanne Murray, Inc.

DURATION

The period of duration of this corporation is perpetual.

PURPOSE

The purposes for which this corporation is organized are to engage in any activity or business permitted under the laws of the United States and the State of Florida.

AUTHORIZED SHARES

1. The aggregate number of shares that the corporation shall have the authority to issue is 1,000,000 shares of capital stock with value of \$1.00 per share.

2. The sum of the value of all the Capital Stock of the corporation that have been authorized and issued shall be the stated capital of the corporation at any particular time.

3. The holders of the outstanding Capital Stock shall be entitled to receive, when and as declared by the Board of Directors, dividends payable either in cash, in property, or in shares of Capital Stock of the corporation.

4. The shares of the corporation are not to be divided into classes.

5. The corporation is not authorized to issue shares in series.

**REGISTERED AGENT**

**BOARD OF DIRECTORS**

1. The initial Board of Directors shall consist of two members, who need not be a resident of the State of Florida or shareholders of the corporation.

SHAREHOLDER POWERS

1. An affirmative vote of three-fourths of the shares of the corporation shall be required for any shareholder action.
2. The shareholders shall have the power to adopt, amend, alter, change, or repeal the Articles of Incorporation when proposed and approved at a shareholder meeting, with not less than a three-fourths vote of the common stock.
3. The holders of the common stock of this corporation shall have preemptive rights to purchase, at prices, terms, and conditions that shall be fixed by the Board of Directors, such of the shares of this corporation as may be issued for money, or any property or service, from time to time, in addition to that stock authorized and issued by the corporation. The preemptive right of any holder is determined by the ratio of the authorized and issued shares of common stock held by the holder and all shares of common stock currently authorized and issued.

PRINCIPAL OFFICE

CUMULATIVE VOTING RIGHTS

The shareholders of this corporation shall be allowed to vote their shares cumulatively so as to give one shareholder as many votes as the number of directors to be elected multiplied by the number of shareholder's shares, to distribute them among as many

candidates as said shareholder may wish. Notice must be given by any shareholder to the President or any Vice President of said corporation not less than 24 hours prior to the time set for the holding of a shareholder's meeting for the election of directors that said shareholder intends to cumulate his or her vote at said election.


