ARTICLE 1. CORPORATE NAME

The name of this corporation is: American Future Value Corporation, and the street address and mailing address of the principal office of this corporation is 18125 Highway 41 N., butte 109, Lutz, Florida 33549.

ARTICLE 11. NATURE OF BUSINESS AND POWERS
