**ARTICLE I

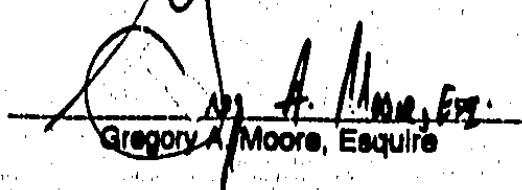

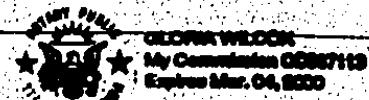
