The undersigned, acting as incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation:

**ARTICLE I**

The name of the corporation is Emerald Coast Canvas, Inc.

**ARTICLE II**

The period of its duration is perpetual.

**ARTICLE III**

The purpose is to fabricate, install and service marine canvas products, including bimini tops and boat covers, and/or any business as permitted under the laws of the United States and the State of Florida.

**ARTICLE IV**

The corporation shall have authority to issue One Hundred (100) shares of common stock, all of one class, One Dollar (\$1.00) par value.

**ARTICLE V**




