ARTICLE 1 - NAME AND MAILING ADDRESS
The name of this corporation is William F. Thom

This corporation is organized for the purpose of any and all lawful business for which corporations may be incorporated under the Florida General Corporation Act.

ARTICLE IV - POWERS
