

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopt the following Articles of Incorporation.

ARTICLE I
NAME and PRINCIPAL ADDRESS

The name of the corporation is: **CRYSTAL BLUE ADVENTURES, INC.**, and the initial principal address of the corporation is: 1777 Pine Channel Drive Summerland Key, Florida 33042.

ARTICLE II
DURATION

The corporation shall exist perpetually unless dissolved according to Florida law.


