## ARTICLES OF INCORPORATION OF SUNGOLD, INC.

# FILED 96 JUL -3 AH IO: 58 SECRETARY OF STATE

The undersigned hereby adopt the following Articles of Incorporation for the purpose FLORIDA of forming a corporation under the laws of the State of Florida:

## **ARTICLE I - Name**

The name of the corporation is **SUNGOLD**, **INC.** The principal place of business of the corporation is 417 Bayshore Drive, Cape Coral, Florida 33904. The mailing address of the corporation is 417 Bayshore Drive, Cape Coral, Florida 33904.

#### **ARTICLE II - Commencement and Duration**
