ARTICLE I. NAME

FARMERS TRUCKING CO TOC. SECRETARY OF STATI

The name of this corporation is:

FARMERS TRUCKING CO INC.

ARTICLE II. PURPOSES

The purposes for which this corporation is formed are: 1. To purchase, to receive by way of gift, subscribe for, invest in, and in all other ways acquire import, lease possess, maintain, handle on consignment, own, hold for investment or otherwise use, exercise, operate, manage, conduct, perform, enjoy, make, borrow, guarantee, contract in respect of, trade and deal in, sell, exchange, mortgage, pledge, deed in trust, hypothecate encumber, transfer, assign and in all other ways dispose of, assemble, build, construct, operate, manufacture, plant, cultivate, produce, market, and in all other ways (whether like or unlike the foregoing), deal in and with property of every kind and character, real, personal, or mixed, tangible, intangible, wherever situated and however held, including, but not limited to money, credits, choses in action, securities, stocks, bonds, warrants, script, certificates, debentures, mortgages, notes on commercial paper and other obligations and evidences of interest in or indebtedness of any person, firm or corporation foreign or domestic or of any government or subdivision, or agency thereof, documents of title, and accompanying rights, and every other kind and character of personal property, real property (improved or unimproved), and the products and avails thereof, and every characte of interest therein and appurtenance thereto, including, but not limited to, mineral, oil, gas and water rights, all or any part of any going business and its incidents, franchises, subsidiaries, charters concessions, grants, rights, powers or privileges, granted or conferred by any government or subdivision or agency thereof, and any interest in or part of any of the foregoing, and to exercise in respect thereof all of the rights, powers, privileges, and immunities of individual owners or holders thereof.

2. To hire and employ agents, servants and employees, and to enter into agreements of employment and collective bargaining

agreements, and to act as agent, contractor, trustee.

- 3. To promote or aid in any matter, financially or otherwise, any person, firm, association, or corporation, and to guarantee contracts and other obligations.
- 4.
