**ARTICLES OF INCORPORATION  
OF

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation:

**ARTICLE I - NAME**

The name of the corporation shall be Apparel Design & Printing, Inc.

**ARTICLE II - PRINCIPAL OFFICE**

The principal place of business and mailing address of this corporation shall be 3335 North Marina Parkway, Lake Wales, Florida 33853.

**ARTICLE III - DURATION**

This corporation shall exist in perpetuity, commencing on August 1, 1996.

**ARTICLE IV - PURPOSE**

This corporation is organized for the purpose of transacting any or all lawful business.

**ARTICLE V - CAPITAL STOCK**

The number of shares of stock that this corporation is authorized to have outstanding at any one time is 10,000 shares, all of which shall be common shares with a par value of \$1.00.

**ARTICLE VI - PRE-EMPTIVE RIGHTS GRANTED**

Every shareholder, upon the sale for cash of any new stock of this corporation of the same kind, class or series as that which he/she already holds, shall have the right to purchase his/her prorata share (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.

#### ARTICLE VII - RESTRICTION ON TRANSFER OF SHARES

A restriction on the transfer or registration of transfer of shares is imposed to obligate the shareholder first to offer the corporation an opportunity to acquire the restricted shares, at the price originally paid.

#### ARTICLE VIII - INITIAL BOARD OF DIRECTORS

This corporation shall one (1) director initially. The number of directors may be increased from time to time by the by-laws, but shall never be less than one. The name and address of the initial director of this corporation is: Abby G. Poole, 2822 Dixie Road, Lakeland, Florida 33801.


#### ARTICLE X - INCORPORATOR


