



The undersigned incorporator, pursuant to Chapter 607, Florida Statutes, hereby adopts the following Articles of Incorporation for Event Media Communications, Inc., a Florida corporation.

Article I. Name

The name of the corporation is: Event Media Communications, Inc.

Article II. Address

Article III. Authorized Shares


