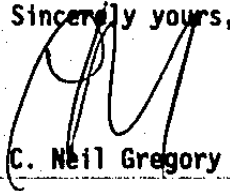

The undersigned subscriber to these Articles of Incorporation, being duly licensed to practice medicine under the laws of the State of Florida, adopts these articles to form a corporation under the Professional Service Corporation Act, F.S. Chapter 621, and other laws of the State of Florida.

ARTICLE I

NAME

The name of the professional service corporation is JAMES J. BUONAVOLONTA, M.D., P.A.

ARTICLE II

PRINCIPAL OFFICE

The principal office and mailing address of this corporation are 649 Eighth Street North, Naples, FL 33940.

ARTICLE III

PURPOSE

The professional service corporation is formed to engage in every phase and aspect of the practice of medicine. 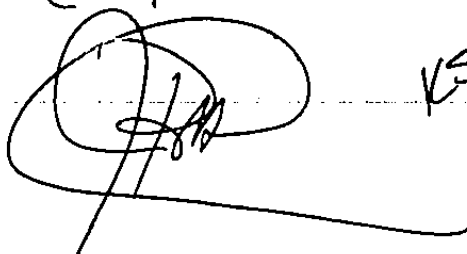
