#### ARTICLES OF INCORPORATION

The undersigned, acting as incorporators of a corporation pursuant to Chapter 607, Florida Statutes adopt the following articles of incorporation for such incorporation.

#### **ARTICLE I**

The name of the corporation is:

This corporation shall exist until dissolved under the name GOODWIN FOREIGN CAR SERVICE, INC. and the nature of the corporation is to engage in any lawful act or activity for which the corporation may be organized under the general Corporation Law of Florida.
