ARTICLES OF INCORPORATION /

OF

INTERNATIONAL CREDIT CORP.

ARTICLE I. NAME

The name of this corporation is INTERNATIONAL CREDIT CORP.

ARTICLE II. PURPOSE

This corporation is organized for the following purpose(s):

a. To engage in any or all lawful business for which corporation may be incorporated under the laws of Florida.

ARTICLE III. POWERS

The corporation shall have the following powers:
