ARTICLES OF INCORPORATION

OF

The undersigned subscriber to these Articles of Incorporation, a natural person competent to confract, here forms a corporation under the laws of the State of $\underline{-F10r1da}$.

ARTICLE I NAME

Any director of the corporation may vote upon any transaction with the corporation without regard to the fact that he is also a director of such subsidiary or corporation.
