ARTICLES OF INCORPORATION OF TOURNAMENTS UNLINITED, INC.

ARTICLE I - NAME

The name of this corporation is TOURNAMENTS UNLIMITED, INC. and its principal place of business and mailing address is 41 West. Michigan Avenue, Orlando, Florida 32806.

ARTICLE II - DURATION

This corporation shall have perpetual existence, commencing on the filing of these Articles.
