The undersigned, desiring to form a corporation for MATE profit under the Florida Business Corporation Act, does hereby LONION certify:

FIRST: The name of the corporation shall be: Jacor Broadcasting of Sarasota, Inc.

SECOND: The address of the principal office and the mailing address of the corporation shall be: 1300 PNC Center, 201 E. Fifth Street, Cincinnati, Ohio 45202.
