## ARTICLES OF INCORPORATION OF ST. AUGUSTINE FINANCIAL CORPORATION

The undersigned incorporator hereby forms a corporation under Chapter 607 of the laws of the State of Florida.

#### ARTICLE 1. NAME

The name of the corporation shall be:

#### ST. AUGUSTINE FINANCIAL CORPORATION

The address of the principal office of this corporation shall be 2806 Alsace Court, Orlando, Florida 32812 and the mailing address shall be the same.

#### ARTICLE II. NATURE OF BUSINESS
