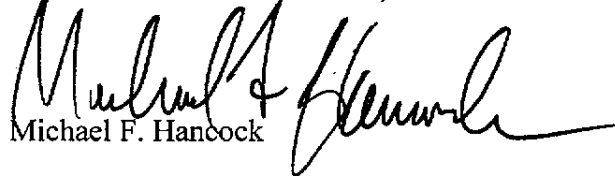

TO THE ARTICLES OF INCORPORATION

Pursuant to the provisions of Section 607.1006 of the Florida Statutes, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation.

1. The name of the corporation is Michael F. Hancock, P.A.
2. The following amendments of the Articles of Incorporation were adopted by the Board of Directors of the corporation in the manner prescribed by the Florida Business Corporation Act:

Article I is amended by deletion of the entire text thereof, and by substitution of the following Article I, Name:

ARTICLE II PRINCIPAL OFFICE

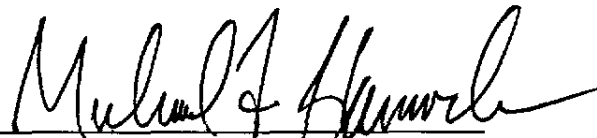
