#### ARTICLES OF INCORPORATION

OF

#### BOAT WORKS OF NORTHWEST FLORIDA, INC

#### ARTICLE I - NAME:

The name of the corporation is BOAT WORKS OF NORTHWEST FLORIDA, INC.

#### ARTICLE II - DURATION:

This corporation shall exist perpetually commencing on the date of filing.

#### **ARTICLE III - PURPOSES:**

This corporation is organized for the purpose of transacting any or all lawful business.

#### ARTICLE IV - CAPITAL STOCK:

This corporation is authorized to issue one thousand (1,000) shares of One Dollar (\$1.00) par value common stock.

This corporation shall have two directors initially. The number of directors may be either increased or diminished from time to time by the bylaws, but shall never be less than one (1). The names and addresses of the initial directors of this corporation are as follows:

The power to adopt, alter, amend, or repeal bylaws shall be vested in the Board of Directors and the shareholders.

ARTICLE XI - RESTRICTIONS ON TRANSFER OF STOCK:

Shares of capital stock of this corporation shall be issued initially to the following persons:

The price and terms at which, and the time within which, such shares may be offered and sold shall be further specified by written agreement among all of the shareholders and this corporation.

#### ARTICLE XII - CUMULATIVE VOTING:

At each election for directors every shareholder entitled to vote at such election shall have the right to cumulate his votes by giving one candidate as many votes as the number of directors to be elected at that time multiplied by the number of shares, or by distributing such votes on the same principle among any number of such candidates.

## ARTICLE XII - CALLING OF SPECIAL MEETINGS:

Special meetings of shareholders may be called by a majority of the outstanding shares.

# ARTICLE XIV - SHAREHOLDER QUORUM AND VOTING:

Fifty-one percent (51%) of the shares entitled to vote, represented in person or by proxy, shall constitute a quorum at a meeting of shareholders.

If a quorum is present, the affirmative vote, fifty-one percent (51%) of the shares represented at the meeting and entitled to vote on the subject matter, shall be the act of the shareholders.

## ARTICLE XV - SHAREHOLDERS MEETING REQUIRED:

Any action of the shareholders of this corporation must be taken at a meeting of the shareholders of this corporation duly called as provided by law.

## ARTICLE XVI - MANAGEMENT OF CORPORATION BY SHAREHOLDERS:

All corporate powers shall be exercised by or under the authority of, and the business affairs of this corporation shall be managed under the direction of, the shareholders of this corporation.

# ARTICLE XVII - DIRECTOR QUORUM AND VOTING:

All of the directors shall constitute a quorum for a meeting of directors.

If a quorum is present, the affirmative vote of all of the directors present, or, if a director or directors have abstained from voting because of an interest in the matter to be voted upon, the affirmative of all of the remaining directors, shall be the act of the Board of Directors.

# ARTICLE XIX - ACTION BY DIRECTORS WITHOUT A MEETING:

The Directors of this corporation may take action by written consent, as provided by law.

#### ARTICLE XX - INDEMNIFICATION:

The corporation reserves the right to amend or repeal any provisions contained in these Articles of Incorporation, or any amendments hereto, and any right conferred upon the shareholders is subject to this reservation.
